## Specification for Anaesthesia machine ;

Anaesthesia Machine for delivering anaesthesia agents to the patients during surgery Anaesthesia machine complete with Anaesthesia gas delivery system.; Circle absorber system.; Precision vaporiser for Sevoflurane ;

Essential accessories to make the system complete Anaesthesia gas delivery system.

Should have provision for delivery of oxygen, nitrous oxide and medical air with pressure gauges. It should have provision to supply oxygen flush of 35-70 litre/min.

Should have independent attachments for connecting central gas supply and pin indexed cylinders. Should have provision for attaching 2 cylinders of O2 and 1cylinder of N2O.

Should have 02 gauges of 02 & 01 gauge of N2O for cylinder supply & 01 pressure gauge for central 02, N20 & Air

Should have 05 tube rotameter ,2 each for O2& N2O & 01 for Air with colour coded bobbin & back lightdisplay

Oxygen and Nitrous oxide should be linked either mechanically or pneumatically to ensure a minimum of 25% oxygen delivery at all times to avoid delivery of hypoxic mixture. It should have chain link mechanism hypoxia guard

It should have gas specific & gas name embossed cylinder yokes with clamping bars each of O2 & N2O & port to connect the ventilator

It should have 2 stage regulators with safety device for high& low pressure of o2 & N2O It should have both audible & visual alarm

It should be supplied with provision of one select Tec gas specific , flow & temperature compensated vaporiser from CE Marked company for sevoflurane .

It should have auxiliary oxygen therapy outlet with flow meter as standard.

It should be supplied with fully Autoclave close circuit system.

It should have three sliding drawers & 4 anti static castors with brakes in front

It should be supplied with all circuits & different sizes of face masks.

It should have facility of connect Air, Oxygen & nitrous with central line & should be supplied with long colour coded hoses for all of them. Should have audio-visual oxygen Failure warning System with Nitrous oxide cut off.

Should have back bar which is ISO pin type to attach vaporizer easily.

Should be supplied with necessary attachments for use of the breathing circuits (Bains, Jackson-Rees and closed circuit etc.,)

Should have top shelf to keep monitors and a table top to keep anaesthetic drugs, equipments, etc. Castor wheels should be durable and moisture resistant & Smooth.

The Anaesthesia machine frame should be made of Stainless steel material

Silicone cushion high quality ,adult and Pediatric face mask of four different sizes -2 each size Standard Circle Absorber System

- Should have adjustable pressure limiting valve, breathing circuit pressure measuring device.

- Should have a bag/ventilator selecting valve integrated onto the absorber.

- Should be suitable to use low flow techniques

- Facility to attach oxygen sensor.


Should have CO2 absorbent chamber canister


