- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्ते</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. 

GENERAL INSTRUCTIONS FOR BIDDERS

The Medical Superintendent, ESIC Hospital Bikaner invites Gem Bid for Supply of Tiffin services for the hospital as per specifications detailed in the Schedule attached. The bidders who fulfill all the terms and conditions may participate in the tender.

1. VALIDITY OF CONTRACT.

The contract shall be valid for a period of two years and may be extendable for another one year on satisfactory performance with mutual consent on same terms & conditions.

2. OPENING OF BID

The technical bid shall be opened as per GeM timelines

3. Validity of rates:

The rates once accepted by the hospital shall remain unaltered throughout period of contract including extended period. The details of different diets are mentioned in schedule 1 of Annexure 'C'. Actual payment to the Contractor shall be made as per actual diet ordered which may vary over the year and in different season as per requirement.

4. Right to accept/ Reject:


The hospital authority reserves the right to reject any or all tender without assigning any reason whatsoever. Also, the hospital authority reserves the right to award any or part or full contract to any successful agency at its discretion and this will be binding on the bidder.

Eligibility Criteria

- 1. The bidder should have an Average annual turnover of 4 Lakh per year for last three years.
- 2. The bidder should have an experience of at least 3 years in providing tiffin services





6. ARBITRATION:


Any dispute and/or difference arising out of or relating to this contract will be resolved by joint discussion of the authorized representative of the concerned parties. However, if the disputes are not resolved by joint discussion, then the matter will be referred for adjudication to a sole arbitrator appointed by Medical Superintendent, ESIC Hospital, Bikaner.



7. RISK CLAUSE:

- The contractor shall at all times have standby arrangements for carrying out the work under the contract in case of any failure of the existing arrangement. All liabilities arising out of accident or death while on duty shall be borne by the contractor.
- In the event of loss/damage of equipment's etc. at the premises of ESIC Hospital, Bikaner due to negligence/carelessness of contractor staff, the contractor shall compensate the loss to ESIC.
- The contractor shall, in performing its part of this agreement, ensure the safety of the building and the persons working in or visiting the ESIC premises and shall indemnify ESIC for any loss or damage caused by any act of the contractor or its employee or its staffs etc.
- If the contractor fails to execute the work order/ supply order within stipulated time,
 MS may be at liberty to get the work executed from other party on market rate and difference of cost will be adjusted from the pending bill/performance security deposit of the contractor.
- **8.** If the contractor is found guilty of supply of adulterated/ unhygienic food or use adulterated/unhygienic ingredients at any time, action shall be taken including termination of contract, forfeiture of performance security and blacklisting of the firm.

9. TERMINATION OF CONTRACT:




- a) The Contract may be terminated in any of the following condition:
 - • If contractor is found involved in any unlawful activity.
 - If at any time, the contractor is found blacklisted by any of the Govt. /semi Govt /ESIC /Private institution.
 - If the contractor is found guilty in any court of law.
 - If the contractor is in repeated violation of terms & conditions and MS, ESIC
 Hospital, Bikaner concludes that the contractor is habitual defaulter and not interested
 in complying with the terms & condition of the
 tender or if the contractor is found to
 have supplied false information/concealed facts at any stage of tender process or
 during currency of contract.
 - If the contractor is found guilty of supplying adulterated/unhygienic food or use adulterated/unhygienic ingredients.
- b) Either of the parties (ESIC or Contractor) can terminate the contract by giving one month notice

10. FORFEITURE OF PERFORMANCE SECURITY:

The performance security may be forfeited in part or in whole in any of the following conditions

- · If the contractor is found guilty of doing any unlawful/corrupt practice.
- · If the contractor intentionally violates terms and conditions set forth in this bid document.
- If the contractor supplies false information/conceals facts at any stage of bid or during the currency of the contract or at any time before the Performance Security Deposit is returned.
- If the contractor is found guilty of supplying adulterated/ unhygienic or use foodAdulterated / unhygienic ingredients.

Any dues pending with the contractor arising in any manner may be adjusted in part or in whole, from the Performance Security Deposit.



SPECIAL TERMS AND CONDITIONS FOR tiffin SERVICE ON CONTRACT

1. IF any staff member of Hospital demands tiffin then bidder has to provide the tiffin at same rate at which tender has been finalized and payment will be directly borne by staff member who orders tiffin, ESICH Bikaner will not be responsible for payment of these tiffin.

2. Only tiffin service is to be provided , no space in hospital will be given for cooking in hospital. Cooking is to be done at bidders premises and bidder will supply food in tiffin to patients .
